Subject: November 2018 NYWYSA Nominating Committee Report

Two (2) positions on the NYWYSA Board of Directors (BOD), 1st Vice President (VP) and Treasurer, are open for election at the November 17, 2018 NYWYSA Annual General Meeting (AGM) to be held at 3:45 P.M. at the Italian American Community Center in Rochester, NY.

An announcement that these positions will be open for election was distributed to the membership on October 16th & 19th, 2018. Nominations of persons interested in serving the membership of the NYWYSA in these capacities are to be sent to the NYWYSA Nominating Committee Chairman Roger J. Best and the NYWYSA State Office. Nominations are to include a resume providing the candidate's qualifications and a cover letter stating the reason(s) for interest in the position.

Incumbent NYWYSA 1st Vice President Hugh Goodridge announced his candidacy for reelection to the position on October 16, 2018. Hugh initially became involved with soccer at the state level in 2009 serving as the NYWYSA State Cup Chairman, a position he has held since then. Hugh also served as the NYWYSA Secretary from 2010 – 2015. He was appointed NYWYSA 1st Vice President at the August 2015 NYWYSA Planning Meeting replacing the current NYWYSA 1st VP Curt Regruit who had assumed the position of NYWYSA President with the resignation Rich Wagner. He was elected to the position by proclamation at the November 19, 2016 NYWYSA AGM.

On October 24, 2018, incumbent NYWYSA Treasurer Lee Wilson announced that he would not be running for reelection. The BOD position of NYWYSA Treasurer will then be open effective November 17, 2018. After that date, Lee will continue to perform the duties and responsibilities of treasurer until a suitable replacement is elected at the November 17, 2018 NYWYSA AGM or is appointed by the NYWYSA BOD.

Individuals interested in applying for the NYWYSA Treasurer position must submit a resume of their qualifications accompanied by a cover letter stating the reason(s) for their interest to: NYWYSA Nominating Committee Chairman Roger J.
